This is to give you notice that HomeServices of Kentucky Inc. doing business as Semonin, REALTORS® (“Semonin, REALTORS®”), HomeServices Relocation, LLC, HomeServices Lending, LLC, Edina Realty Title, Inc. doing business as HomeServices Title, Inc. (“HomeServices Title, Inc.”), and HomeServices of Kentucky Insurance, LLC doing business as HomeServices Kentuckiana Insurance (“HomeServices Kentuckiana Insurance”) are part of a family of companies (the “Affiliated Companies”), and each may refer to you the services of another.
